Shareholders are advised that Greenbay has closed its bookbuild announced earlier today, 16 March 2017.

The amount of capital raised was approximately ZAR2 billion (equivalent to approximately GBP127 million) through the placing of 1 324 503 311 new shares at a price of R1.51 per share on the South African register and GBP0.095 on the Mauritian register (the "new Greenbay shares").

Subject to approval by the JSE Limited ("JSE") and the Stock Exchange of Mauritius Ltd ("SEM"), listing and trading of the new Greenbay shares on the JSE and SEM is expected to commence at the opening of trade on Monday, 27 March 2017. Investors will have their CSDP and CDS accounts credited with the new Greenbay shares on Monday, 27 March 2017.

Following the issue of the new Greenbay shares, the Company will have a total of 6 302 299 068 shares in issue.
